Security Agreement:

Please read carefully and sign as indicated. Giving Children Hope and Gifts In Kind International reserve the right to terminate your organization's registration if your organization does not meet the basic requirements or violates any of the seven conditions listed below.

1. Your organization is an organization described in Section 501(c)(3) of the federal Internal Revenue Code. It is exempt under Section 501(c)(3) and is not a private foundation (other than an operation foundation described in Section 4942(j)(3)).
2. The goods will be used solely for the care of the ill, needy, or youth (as those terms are defined in applicable Treasury regulations).
3. The use of the goods will be related to the purpose of the organization that makes it tax exempt.
4. The goods will not be transferred by the organization in exchange for money, property, or other services. Neither will the goods be BARTERED FOR, TRADED or SOLD. You agree that this restriction may be enforced by a court entering equitable relief including, but not limited to, injunctive relief.
5. Donations must be used by the recipient organization to operate its offices or be distributed directly to those in need, free of charge. Donations cannot be used for FUNDRAISERS, RAFFLES, or AUCTIONS. Donations cannot be given to volunteers or staff members.
6. Organization must maintain and make available adequate books and records of donations as required by applicable regulations.
7. Giving Children Hope reserves the right to limit and/or restrict quantities requested by any organization.

Organizations using donated products for purposes other than those intended will be removed from the program, and legal action will be taken. Breach of any of your organization's obligation under paragraphs 2,3,4 and 5 listed above, will be a material breach of this contract, entitling Gifts In Kind International to recover any and all goods donated. In this connection, your organization agrees that the remedy of money damages is not exclusive and is adequate and that Gifts In Kind International will be immediately and irreparably damaged by any such breach. In such event, your organization consents to a temporary, preliminary and permanent injunction in favor of Gifts In Kind International, forbidding your organization from making any disposition of the goods and requiring your organization to return immediately all such goods to Gifts In Kind International, as it directs.
